Meets the 3rd Thursday after the 1st Monday, quarterly.

If you live in Bernards Township and share our vision of: *A Caring Community, Embracing Our Past, While Creating Our Future Today*, you've taken the first step in qualifying as a Bernards Township volunteer for a Board/Commission/Committee/Task Force. The next step is to complete the attached "Tap the Talent" questionnaire.

Once your "Tap the Talent" application is received, it is reviewed by the Township Committee and kept on file until there is a term expiration or resignation of a current volunteer.

This brochure represents just a small sampling of service opportunities available in Bernards Township. Contact the Recreation Department, YMCA, or your local house of worship for additional opportunities.

The Township Committee wants to ensure a mix of new and experienced members on our Boards/Commissions/Committees/Task Forces. Appointments are made by the Township Committee and there is a growing list of willing volunteers. Service in the past does not necessarily assure a re-appointment.

250th Anniversary Task Force - Promotes recognition throughout the Township and participation by Township residents in the 250th anniversary of the townships charter. (Resolution #090026)

Meets 4th Thursday after 1st Monday, monthly.

Agricultural Advisory Committee - Supports the Agricultural community and its continued contribution to the quality of life in Bernards Township, by preserving agricultural land, providing advocacy for agricultural viability and promoting public education. (§2.31 Revised General Ordinances)

Board of Health - Has all the powers and duties conferred by Chapter 3 of Title 26 of the Revised Statutes of New Jersey, as amended and supplemented, N.J.S.A. 26:3-1, et seq., and by any other law or statute. This Board has the power and authority to pass, alter and amend ordinances and make rules and regulations concerning the public health within its jurisdiction. (§2.10 Revised General Ordinances)
Meets 2nd Thursday after 1st Monday, monthly (no meetings in July, August and November).

Cable TV Task Force - The Task Force is charged with identifying the Township's cable related needs and evaluating the current performance of the cable franchise with Cablevision. (Resolution #080057)
Meets 4th Thursday after 1st Monday, monthly (no meetings in April, November and December).

Charter Day Committee - Volunteers who assist Parks and Recreation in the organization and administration of the annual Charter Day celebration. (Resolution #070053)
3rd Friday of Month Jan., Feb., March, then bi-weekly April thru May.

Deer Management Advisory Committee - Develops an annual community based deer management plan for consideration by the Township Committee and submission to the New Jersey State Division of Fish and Wildlife. They closely monitor the results of the deer management program via a combination of recreational hunting tallies, accurate deer kill counts on Township roads and realistic estimates for the Interstate Highway segments within the Township's borders, tallies from commercial harvesting contractors, when utilized, and if/as necessary, consideration of a periodic aerial survey, in order to obtain an accurate census of the deer population. (Resolution #040042)
Meets 1st Thursday after 1st Monday, monthly.

Environmental Commission - Has the power to conduct research into the use of the open land areas of the Township and may coordinate the activities of unofficial bodies organized for similar purposes. It keeps an index of all open areas, publicly or privately owned, including

open marshlands, swamps and other wetlands, in order to obtain information on the proper use of such areas. This commission, may, from time to time, recommend to the Planning Board plans and programs for inclusion in a Township Master Plan and the development and use of such areas. The Environmental Commission also reviews and comments on all Planning Board and Zoning Board applications relative to environmental concerns. (§2.18 Revised General Ordinances)
Meets 2nd Monday, monthly.

Fire and Rescue Services (Basking Ridge Fire Co. #1 and First Aid; Liberty Corner Fire Company and Liberty Corner First Aid
Emergency Services in Bernards Township are 100% volunteer organizations, and are actively looking for township residents, or those that work in the community, to join as volunteer firefighters, EMT's, ambulance drivers, and as administrative support. Junior Memberships are also available. All training and equipment is provided and no prior experience is necessary. Willingness to work as part of a professional team, helping others when they need it most is a must. (§2.14 and 2.16 Revised General Ordinances)
Meeting times and training varies.

Golf Advisory - Oversees the municipal operation of the Coakley-Russo Memorial Golf Course at the Lyons VA Hospital. The group consists of residents and VA Lyons Hospital representatives. It receives from the Director of Parks & Recreation the proposed annual budget and provides comment on the priorities, facility improvements and maintenance, fees and participation levels anticipated in the budget to the Township Committee. It reviews all golf related initiatives and offers comment. (§2.32 Revised General Ordinances)
Meets 3rd Monday in March, May, July, September and October

Green Team - An advisory committee charged with focusing attention on "Green" issues in Bernards. Works to make the township a model of government which benefits our residents now and far into the future with green community initiatives which are easy to replicate and affordable to implement. (Resolution #070292)
Meets 4th Tuesday after 1st Monday, quarterly

Library Board - This board is the policy-maker of the Library. With the Library Director, the Board of Trustees analyzes the needs of the community to determine a plan for library service. It sets priorities and decides on the course of action to implement the plan. The Trustees and Director develop annual operating and capital budgets that provide the library service, programs, materials and staff training. Trustees, working on behalf of the community, are advocates of excellent library service and help to create public awareness and generate support for the Library. They may represent the library at Regional and State events. (§2.19.2 Revised General Ordinances)

Meets 4th Wednesday after 1st Monday, monthly.

Local Emergency Planning and Flood Mitigation Committee - The emergency service unit of the local government formed to help carry out the basic governmental functions of maintaining the public peace, health and safety during an emergency in accordance with N.J.S.A. App. A:9-41. This shall include plans and preparations for protection and relief, recovery and rehabilitation from the effects of any emergency. (§28-1.2 Revised General Ordinances)

Meets 3rd Wednesday after 1st Monday, in January, May and September.

Municipal Alliance/Youth Services Commission - Serves the Township in accordance with P.L. 1989, C. 51, and the guidelines of the Somerset County Municipal Alliance Plan Steering Sub-Committee. The mission of the Alliance is to provide consultation, programs, training, and resources to the Bernards Township community with the goal of preventing and reducing the use and abuse of alcohol, tobacco, and other drugs. The commission also oversees the Teen Center. (§2.35 Revised General Ordinances)

Meets 1st Tuesday after 1st Monday, except July & August.

Parks, Pathways & Recreation Committee - Receives from the Director of Parks & Recreation the proposed annual budget and provides comment on the priorities. It reviews all park-related, pathways, and recreation program initiatives and makes recommendations to the Director. It acts as a catalyst for volunteer help with Township-sponsored and supported park and open space programs both by active

participation and by enlisting others to serve. It prepares and submits to the Township Committee a greenways plan for the Township. It evaluates, prioritizes and assists in developing greenways properties through the development of appropriate criteria. The greenways plan consists of recommendations concerning the nature of the interests in such real estate to be acquired, dedicated, preserved or maintained and the greenway purposes for which such land should be utilized. It provides guidance and support to the Township Committee and Planning Board on issues and matters designed to effectuate greenway purposes. (§2.28-2 Revised General Ordinances)

Meets 1st Monday, monthly.

Planning Board - Is governed by the Municipal Land Use Law (MLUL; N.J.S.A. 40-55D) and local zoning laws. This board is commonly referred to as the board of "permitted activities." The essential duties are to deal with policy (the Master Plan) and the implementation of that policy through the site plan and subdivision ordinances. These ordinances establish a series of ground rules to be met by an applicant. If an applicant meets the requirements of the particular ordinance, the board must approve the subject application. (§21-4 Revised Land Use Ordinances)

Meets 1st and 3rd Tuesdays after 1st Monday, monthly.

Pool Commission - Develops policy and regulations concerning pool membership and all forms of recreation, playground and public entertainment activities carried on in connection therewith. Pool membership is required. (§2-20.2 Revised General Ordinances)

Meets 4th Monday, monthly.

Sewerage Authority - Is vested with all powers and duties conferred by N.J.S.A. 40:14A-1, et seq. necessary for the operation, conduct, control, management and continuance of said corporation and the sewerage system and the properties, real and personal, acquired and held by it. (§2.13 Revised General Ordinances)

Meets 2nd Tuesday after 1st Monday, monthly.

Shade Tree Commission - Has the power and authority for the regulation, planting, care and control of shade and ornamental trees

and shrubbery upon or in the highways, parks or parkways within the jurisdiction of the Township and shall exercise all powers and rights and be subject to all duties provided in Chapter 325 of the 1915 Laws of New Jersey (N.J.S.A. 40:64-1 et seq.), as amended and supplemented. (§2.17 Revised General Ordinances)

Meets 2nd Wednesday after 1st Monday, monthly.

Zoning Board of Adjustment - Is governed by the Municipal Land Use Law (MLUL; N.J.S.A. 40-55d) and local zoning laws. It holds quasi-judicial authority with issues dealing with land use. It is commonly referred to as the board of "nonpermitted uses." Zoning Boards deal with the issuance of variances. Variances are based upon the individual municipality's zoning ordinance. The zoning ordinance establishes specific requirements for a given land area within the municipality which regulate not only the uses permitted in that area but the size of the parcels, setback required, parking, signs, conditional uses and numerous other regulations. An applicant must meet specific criteria contained in the MLUL by satisfying certain legal standards of proof; the burden is upon the applicant to show that he or she is entitled to the specific relief required. (§21.5 Revised Lane Use Ordinances)

Meets 1st Wednesday after 1st Monday, monthly.
