PROCESS COMPLAINT PROCEDURE

Following is the process put in place to address complaints by any person who believes that Bernards Township, acting through its agents or employees, may have violated RLUIPA.

Should any Township personnel receive a verbal complaint, it should be communicated immediately, in writing, to the Municipal Clerk, who will offer and provide the *Complaint Against the Township of Bernards* Form to the complainant.

Any submitted *Complaint Against the Township of Bernards* forms should be forwarded to the Municipal Clerk immediately upon receipt. The Municipal Clerk shall log the complaint and forward to the complaint Investigator.

It is the responsibility of the Municipal Clerk to accept and maintain each complaint and any proposed or actual action taken by the Township in response to the complaint.

- Copies of *Complaint Against the Township of Bernards* forms, shall be logged in \\ADMINSRV7\ISBR_Documents \Complaint Log
- The log will indicate the name of the complainant, date of complaint receipt, name of the respondent/investigator and the date of the Township's response

The Township Administrator, or his/her designee, will serve as the investigator and examine complaints and respond, in writing, to the complainant within **15 days**, providing the Municipal Clerk a copy of the response for their files and log. If the Township Administrator determines that further investigation is necessary, the Township Administrator may refer the complaint to Stephen O. Davis, Esq., of the firm DiFrancesco Bateman, Coley, Yospin, Kunzman, Davis, Lehrer & Flaum, P.C.

The Municipal Clerk is responsible for providing copies of the written complaints and the Township's responses to the Township Committee. These documents will be included in the Annual Compliance report. This information must be reported by November 26, 2017, November 26, 2018, November 26, 2019, November 26, 2020 and March 22, 2022.

The *Complaint Against the Township of Bernards* form shall be placed on the Bernards Township Website in the Documents section of the Planning and Zoning Departmental page.
