Mr. Stephen E. Barcan, Esq., counsel for the applicant, advised the board members that the Letter of Interpretation (L.O.I.) had not been issued as of yet and asked for a checklist waiver. He added that the L.O.I. would be a condition of the resolution should the board act favorably on the application.

Mr. Timko, PE, Township Engineer and David Schley, AICP, PP, Township Planner agreed that this was a formality since the area of proposed development was nowhere near the wetlands.

Public Hearing

Verizon Corporate Services Group Inc. (ZB-16-026); Block 804, Lots 2.01 & 16; 295 North Maple Avenue; Floor Area Ratio Variance, Bulk Variances, Preliminary & Final Site Plan for Phase A and Preliminary Site Plan for Phase B.

Stephan E. Barcan, Esq.,attorney with *Wilentz, Goldman & Spitzer PC,* Woodbridge, NJ, and counsel for the applicant, addressed the Board and outlined the proposed development in Phase A and Phase B of the proposed project. Phase A primarily involved construction of a Parking Deck and Phase B involved construction of an Amenity Building. He also discussed the relief outlined in Mr. Schley's memo dated December 30, 2016 and stated that, in his opinion, the "catch all provision" in the public notice was sufficient to cover those variances called out in the memo. Counsel Warner and Chairman Rhatican agreed.

Robert C. Moschello, PE, engineer with *Gladstone Design Inc.*, Gladstone, NJ and engineer for the applicant, was sworn in and introduced a power point presentation. He reviewed the engineering issues that would be addressed by the proposed project. For a full discussion of the presentation, please refer to the transcript.

Mr. Moschello concluded his testimony however he assured the Board that he would be available for questioning as the application was presented.

Several residents questioned Mr. Moschello about potential noise issues associated with project construction and light spillage from the lights from the top level of the proposed parking deck. The placement of a temporary parking lot on the existing ball fields, landscaping and the request for three (3) internally illuminated Verizon logo signs were also discussed. For a full discussion of the concerns expressed by the residents and board members, please refer to the transcript.

As a result of the residents' concerns, the board members decided to schedule a site visit on January 14, 2017, 10:00 AM.

COMMENTS FROM MEMBERS OR STAFF

Hearing no comments from either board members or staff, Chairman Rhatican asked for a motion to adjourn. Ms. Mastrangelo moved, Mr. Surano seconded and by unanimous Voice Vote, the meeting was adjourned at 10:45 PM.
