The Environmental Commission notes the proposed multi-purpose turf field as part of Phase II of this project. The 2014 Application and Approval (Item #10 on the Application Rider) lists an "artificial" turf field, however the Current Amended Application list a "turf field". If the intended playing surface is to be "artificial", the Environmental Commission would like to make the Applicant aware of the website www.epa.gov/tirecrumb (Federal Research Action Plan on Recycled Tire Crumb Used on Playing Fields and Playgrounds). This website provides the latest information on the commonly used synthetic field infill material known as tire crumb or crumb rubber. If the

intended playing surface is to be natural (grass), the Environmental Commission would like to make the Applicant aware of its website on organic lawn care

(http://www.bernards.org/boards commissions/environmental/ec organic lawn care.aspx). This website provides resources to eliminate the use of synthetic lawn care products and fertilizers. It also has a link to the Township's 2008 Integrated Pest Management Resolution.
