Thomas J. Malman, Esq., representing LCB Senior Living made a presentation to the committee on the proposed development on the property of a new senior living facility consisting of approximately 94 units - 67 assisted living units and 27 memory care units, ten percent of which will be affordable units. They are requesting an amendment to the E-4 zone to permit the project.

Tedd Dole, Rob Moschello and Lee Blum of LCB spoke about the suitability of the site, staffing and their marketing research. They indicated the facility would be tax positive for the township and have a low traffic impact. They are sensitive to the demands on the volunteer EMS services and have already reached out to the BRFC #1 Chief and Atlantic Health Care to explore private ambulance services. They indicated that the proposed affordable housing set-aside could be adjusted upwards.

The committee made no decision regarding the proposal.

If the Contractor fails to complete the work within the specified time plus extensions, the Contractor shall be responsible to the Township for liquidated damages in the sum of \$500.00 per day for every day thereafter until the completion and acceptance of the work. - 12. In accordance with bid specifications, if the Contractor, upon notification by the Township of Bernards, fails to execute the contract prepared by the Township attorney within ten (10) days of such notification with the Township of Bernards, the Township may rescind the award of the bid to the Contractor and award the contract to another bidder, and shall have the right to proceed against the guaranty accompanying the bid.

WHEREAS, in accordance with Chapter 72, P.L. 1994, the Township Committee shall not need the approval from the Director of the Division of Local Government Services since the estimated tax levy will not exceed 105% maximum allowed. Approval will enable the Township to meet its financial obligations, maintain the tax collection rate, provide uniformity for tax payments, and save the unnecessary cost of interest expenses on borrowing.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BERNARDS, on this 29th day of May, 2018, as follows:

- 1. The Bernards Township Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the Township for the third installment of 2018 taxes.
