<u>Resolution #2019-0370</u> - In Recognition of Anjali Dahiya 2019 Reusable Bag Design Challenge Winner WHEREAS, it is the desire of the Township Committee of the Township of Bernards to promote matters which benefit the health, welfare, comfort, and safety of the citizens of the community; and

WHEREAS, Bernards Township wishes to encourage positive, environmentally-sound choices; and

WHEREAS, a substantial quantity of non-biodegradable single use plastic bags ends up as unsightly litter on our roadsides and in our trees, in our storm drains and consequently in our waterways where they can be devastating to marine life and seabirds; and

WHEREAS, plastic bags do not decompose and only break down into smaller pieces that pollute our seas and the Township Committee wishes to promote the use of reusable bags; and

WHEREAS the Township Committee of the Township of Bernards, County of Somerset, State of New Jersey adopted on May 14, 2019 Resolution 2019-0236 endorsing the encouragement of the residents of Bernards Township to use re-usable shopping bags and reduce the number of single use bags that are currently being used; and

WHEREAS, to communicate this need, the Environmental Commission sponsored a *2019 Reusable Bag Design Challenge* for Bernards Township school children with the winning design to be used to decorate re-usable bags and that these bags will be distributed to the residents of Bernards Township, free of charge, while supplies last; and

WHEREAS, Bernards Township school children submitted designs with one student's design selected as the winning design,

NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Bernards that we do hereby congratulate Anjali Dahiya, whose design will be used on the reusable bags, and congratulate all the participants on their participation and accomplishment.

<u>Resolution #2019-0383</u> - Bernards Township Housing Rehabilitation Program Authorizing and Approving Deferred Loan Agreement to Kathy Marie Denuel, 39 Baldwin Court - Block 9203, Lot 4.11 WHEREAS, Bernards Township (hereinafter referred to as "Township") has authorized Central Jersey Housing Resource Center ("CJHRC") to administer the Bernards Township Housing Rehabilitation Program; and

WHEREAS, Central Jersey Housing Resource Center (CJHRC) is a nonprofit collaboration of businesses, financial institutions, social service agencies, public officials and housing advocates who work to increase the accessibility and availability of affordable housing in Central New Jersey; and

WHEREAS, CJHRC currently operates a centralized housing resource information center in Somerset County and is a HUD certified agency specialized in the state and federal housing regulations; and

WHEREAS, the principal goal of the Bernards Township Housing Rehabilitation Program is to provide funding for affordable unit qualified owners to bring substandard units up to code; and

WHEREAS, Kathy Marie Denuel whose principal address is 39 Baldwin Court Basking Ridge, County of Somerset, in the State of New Jersey 07920 (the "Property") is an owner of an affordable housing unit; and

WHEREAS, Ms. Denuel has submitted an application to the Bernards Township Housing Rehabilitation Program for funds to be provided by way of a deferred loan to rehabilitate a central air unit and furnace; and

WHEREAS, Ms. Denuel is eligible to receive funding for the rehabilitation of her owner-occupied unit under the program pursuant to the Uniform Housing Affordability Controls at N.J.A.C. 5:80-16.1 et seq.; and

WHEREAS, the funding will be provided to the Ms. Denuel by way of a ten-year, interest free, amortized depreciating loan in the amount of Eight Thousand Four Hundred and Thirty-Five Dollars (\$8,435.00).

NOW BE IT RESOLVED, by the Township Committee of the Township of Bernards that we do hereby approve the deferred loan agreement for the funds to be used for the rehabilitation on the property as set forth in the Deferred Loan Agreement and Rehabilitation Construction Contract; and

NOW THEREFORE BE IT FURTHER RESOLVED, by the Township Committee of the Township of Bernards that we do hereby authorize the Mayor and Clerk to execute the agreement and other required legal documents with Ms. Denuel on behalf of the Township; and

NOW THEREFORE BE IT FINALLY RESOLVED, by the Township Committee of the Township of Bernards that a copy of this resolution be on file and available for public inspection, in the office of the Bernards Township Municipal Clerk's office, Municipal Building, 1 Collyer Lane, Basking Ridge, New Jersey 07920.

<u>Resolution #2019-0384</u> - Authorizing Township Second Amendment to Settlement Agreement with Bernards Plaza Associates, LLC and Court Associates, LLC

WHEREAS, the TOWNSHIP OF BERNARDS, a municipal corporation of the State of New Jersey, County of Somerset, having an address at Town Hall, One Collyer Lane, Basking Ridge, NJ 07920 (hereinafter the "Township"); and BERNARDS PLAZA ASSOCIATES, LLC, a New Jersey limited liability company, having an address at 820 Morris Turnpike, Short Hills, NJ 07078, (hereinafter "Bernards Plaza"); and CROWN COURT ASSOCIATES, LLC, a New Jersey limited liability company, having an address at 820 Morris Turnpike, Short Hills, NJ 07078, (hereinafter "Crown Court"); collectively, the Township, Bernards Plaza and Crown Court shall be referred to as the "Parties," now desire to enter into a Second Amendment to Settlement Agreement; and

WHEREAS, the parties entered into a Settlement Agreement on March 29, 2018 ("Settlement Agreement") that provided for the development of thirty new affordable housing units at Bernards Plaza, development of four new affordable housing units at Crown Court, and the extensions of the affordability controls for 19 existing units at Crown Court; and

WHEREAS, on May 15, 2018, the Township adopted the Rezoning Ordinances as set forth in the Settlement Agreement and the Crown Court Overlay Zone is now codified at Township Code Section 21-79A.1, <u>et seq.</u> and the Multifamily Housing Overlay Zone within the B-5 Zone is now codified at Township Code Section 21-10.8.1.f; and

WHEREAS, on April 18, 2019, Bernards Plaza and Crown Court executed an Amendment to the Settlement Agreement to ensure that the affordable housing units satisfy the applicable regulations, the Uniform Housing Affordability Controls, <u>N.J.A.C.</u> 5:80-26.1, et seq. and the Amendment to Settlement Agreement is on file with the Township Clerk.

NOW, THEREFORE, BE RESOLVED, that the Second Amendment to the Settlement Agreement is as follows:

- 1. Establishes certain obligations to effectuate Bernards Plaza's acquisition of Block 8501, Lot 44 (the "Open Space Parcel") from the Township pursuant to Paragraph 3.4 of the Agreement; and
- 2. The parties agreed to obligations and covenants as set forth in the Second Amendment to Settlement Agreement dated August _____2019, including:
 - a. The Township shall mow and shall periodically mow the Open Space Parcel until the date of closing; and
 - b. Upon the Township Committee's approval of this Amendment and the full execution of this Amendment, Bernards Plaza will promptly deposit \$125,000 into the trust account of McElroy Deutsch Mulvaney & Carpenter, LLP ("MDMC") for the acquisition of the Open Space Parcel; and
 - c. Upon notice that the funds have been deposited into MDMC's trust account, the Township shall, as owner of the Open Space Parcel, execute an application (General Permit #17) to the NJDEP Division

TOWNSHIP COMMITTEE MINUTES 09/10/2019 Page 13 of 14 of Land Use Regulation for a proposed walking trail. Bernards Plaza shall prepare the application and shall reimburse the Township for its reasonable costs and expenses in reviewing and submitting the application; and

- d. Upon the NJDEP's approval of the proposed walking trail, Bernards Plaza will apply to the Township Planning Board for approval of same. If the Township still owns the Open Space Parcel at that time, the Township will execute the application form as owner, but Bernards Plaza will be the applicant.
- e. Within forty-five (45) days of the notice that the funds have been deposited into MDMC's trust account, the Township will adopt an ordinance ("Ordinance") amending the zoning of the Open Space Parcel to be part of the B-5 zone district, which would effectively permit private passive and/or active recreational activities. The proposed Ordinance is attached hereto as **Exhibit A**.
- f. If the required procedures are followed and no appeal of the Ordinance is filed within 45 days after the adoption of the Ordinance, the closing of the Open Space Parcel will occur within the next ten days. At the closing, MDMC will release the \$125,000 from escrow and the Township will convey to Bernards Plaza a Deed for the Open Space Parcel.
- 3. Other than as set forth above, no other provision of the Agreement is amended, altered or modified by this Amendment.
- 4. The Amendment shall be governed by the same terms and provisions as set forth in the Settlement Agreement at Article VIII-Cooperation and Compliance, Article IX-Notices, and Article X-Miscellaneous.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Mayor and Township Clerk are authorized to execute the Second Amendment to Settlement Agreement.
