CALL TO ORDER

The mayor called the meeting to order at 8:02. Those assembled saluted the flag and the mayor read the Open Public Meetings Act statement in accordance with the law.

PUBLIC WORK SESSION

<u>Resolution #2020-0234</u> - Establishing a Human Relations Advisory Committee

The clerk stated that 23 e-mails in support of the proposed resolution were received outside of the meeting and forwarded to the township committee as correspondence. Harris provided background and discussed different structures / partnerships that other municipalities used in creating such a group. Harris recommends this type of committee be created to recognize Bernards Township's changing and diverse community and to call into action understanding and acceptance. Esposito, Carpenter and Fields stated that a "committee" format may not be the best way to proceed and advocated for a "forum", or group, with a township committee liaison. Baldassare supported the resolution as a starting point and said adjustments could be made to incorporate everyone's ideas.

The mayor opened the floor for public comment on this topic only.

The mayor closed public comment. The committee will consider comments and revisit.

WHEREAS, in the United States of America, we are fortunate to live in a democratic society where checks and balances are created to ensure that all citizens receive equal protection of the laws; and

WHEREAS, Bernards Township wants to ensure that all citizens have the right to participate meaningfully and equally in self-government; and


WHEREAS, Bernards Township is a community composed of people with a wide variety of faiths, philosophies, backgrounds and lifestyles; and

WHEREAS, Bernards Township believes in the inherent dignity and worth of each human being and that our community can become stronger, more cohesive and more interesting by embracing its diversity, by recognizing and celebrating the differences amongst individuals, and capitalizing on the strengths resulting from these differences; and

WHEREAS, Bernards Township recognizes diversity works best when a community explores these differences in a safe, positive, and nurturing environment.

NOW, THEREFORE, BE IT RESOLVED, by the Bernards Township Committee of the Township of Bernards, County of Somerset, State of New Jersey that the following be adopted:

1. The Township Committee hereby authorizes the establishment of a committee to be named the "Human Relations Advisory Committee" dedicated to fostering an atmosphere of understanding and acceptance of



each individual so as to demonstrate that Bernards Township is a great place to live, work and grow providing residents a unique opportunity to recognize, appreciate and celebrate the many cultures that make up Bernards Township; and

- 2. The purpose and mission of the Human Relations Advisory Committee shall be as follows:
 - (a) To advise the Township Committee on ways to promote ethnic and cultural harmony among all Township residents;
 - (b) To advise on ways to encourage goodwill, cooperation, and conciliation among the multicultural and/or otherwise diverse residents of the Township;
 - (c) To recommend educational and cultural programs to foster unity and develop a sense of community; and
 - (d) Such other duties as may be agreed upon by the Human Relations Advisory Committee and approved by the Township Committee.

NOW, THEREFORE, BE IT FURTHER RESOLVED the membership of the Human Relations Advisory Committee shall be limited to two Township Committee Liaisons, of differing political parties if possible, and seven members who shall serve for terms of three years; except that of the initial appointments, two members shall serve for a term of one year, two members shall serve for a term of two years and three members shall serve for a term of three years. Vacancies shall be filled for the balance of unexpired terms. Members shall serve without compensation and will, to the greatest extent possible, reflect the diversity of Bernards Township. Diversity shall be meant to include, but not limited to the following: race, ethnicity, persons of faith and non-believers, sexual orientation, sex gender identity, disability, socioeconomic status, cultural orientation, physical abilities, political beliefs, and national origin and status. Committee members shall include:

- (a) Police Chief or designee
- (b) Member of the clergy or designee
- (c) Superintendent or designee of the Bernards Township School District
- (d) Four members of the public, which may include one high school student

NOW, THEREFORE, BE IT FINALLY RESOLVED by the Township Committee of the Township of Bernards that the Bernards Township Human Relations Advisory Committee be established and be organized immediately upon its appointment by all members by the Township Committee.

WHEREAS, the Township of Bernards owns the real property identified as Block 8401, Lot 23, consisting of approximately 4.397± acres, and located along King George Road in the Township of Bernards, County of Somerset, State of New Jersey; and

WHEREAS, the Property contains an "English Barn," "Farmhouse," Wagon House," "Cow Shed," and other ancillary structures, which are on the New Jersey Historic Register and the National Register of Historic Places; and

WHEREAS, the Township and the Friends of the Kennedy-Martin-Stelle Farmstead, Inc. (the "Friends") entered into Lease Agreement C1775-1, dated March 29, 2005, entered into an Amendment to Lease Agreement C2106-1, dated June 15, 2010, entered into a second Amendment to Lease Agreement C2181-1, dated February 14, 2012; and entered into a third Amendment to Lease Agreement C2320-1, dated November 30, 2015; and

WHEREAS, the lease prohibits provision of professional engineering services, however, the Township Committee determined on 05/28/2019 by Resolution 2019-0264 that it was in the best interest of the community to provide limited consulting services to the Farmstead and authorized the Township Engineer to provide engineering services to the Friends expressly for the development of a conceptual site plan for the future development of the Farmstead; and

WHEREAS, working with Friends of the Farmstead, the Township Engineer's Office prepared a conceptual plan to ensure appropriate improvements and future overall usability of the site; and

WHEREAS, Township Committee members Harris and Fields, the Friends of the Farmstead, the Township Engineer, the Assistant Township Engineer, and neighbors met multiple times during 2019 and 2020 including at the Township Committee meeting on 03/10/2020 and comprehensively discussed parking, the driveway, landscape buffer and other site topics, resulting in many revisions to the concept.

NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Bernards that the conceptual site plan dated 3/18/20 prepared by Township Engineer Thomas Timko, P.E., is hereby approved.

WHEREAS, the Township of Bernards owns the real property identified as Block 8401, Lot 23 (formally known as Block 185, Lot 20.03), consisting of approximately 4.397± acres, and located at 450 King George Road in the Township of Bernards, County of Somerset, State of New Jersey (the "Property"); and

WHEREAS, the Property contains an "English Barn," "Farmhouse," Wagon House," "Cow Shed," and other ancillary structures, which are on the New Jersey Historic Register and the National Register of Historic Places; and

WHEREAS, the Township and the Friends of the Kennedy-Martin-Stelle Farmstead, Inc. ("Friends") entered into Lease Agreement C1775-1, dated March 29, 2005, for the Property (the "Lease"), which was thereafter amended to increase the term of the Lease; and

WHEREAS, Sections 2 and 3 of the Lease provide that Friends may provide access to Township residents for meetings and other appropriate events, provide alternate uses, and sublet or assign any interests in the Lease, subject to the prior written approval of the Township; and
