<u>ORDINANCE #2446</u> - An Ordinance of the Township of Bernards Appropriating \$4,912,435.00 for Various Capital Improvements – Public Hearing

The clerk read the ordinance by title and the mayor opened the public hearing. Todd Edelstein, Riverside Drive commented that money for capital improvements should only be used for immediate public safety issues this year. No other comments were heard, and the hearing was closed.

NEW BUSINESS

<u>Resolution #2020-0209</u> - Authorizing a <u>Shared Services Agreement with the Borough of Peapack and Gladstone, the Borough of Bernardsville, the Township of Bedminster, and the Township of Bernards, for the Establishment and Operation of a Shared Municipal Court.</u>

Belardo recused himself and did not participate in this discussion.

Motion by Harris, second by Fields, to table Resolution #2020-0209 until the next township committee meeting in order to gather additional information; specifically attaching the costs to join the court to the agenda, obtain an independent attorney to review the agreement, and to secure a Memorandum of Agreement with Bedminster.

WHEREAS, the Township of Bedminster ("Bedminster"), the Borough of Peapack and Gladstone ("Peapack-Gladstone"), the Borough of Bernardsville ("Bernardsville") and the Township of Bernards ("Bernards") have reviewed their needs, resources and personnel and have found that they can assist each other at considerable savings to the tax payers of each municipality by establishing and operating a shared municipal court; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:65-1, <u>et seq.</u>, any municipality of the State of New Jersey may contract with any other municipality for the shared provision within their several jurisdictions of any service that any party to the agreement is empowered to provide within its own jurisdiction; and

WHEREAS, pursuant to N.J.S.A. 2B:12-1(c), two or more municipalities, by resolution, may agree jointly to provide for courtrooms, chambers, equipment, supplies and employees for their municipal courts and agree to appoint judges and administrators without establishing a joint municipal court; and

WHEREAS, in a Shared Municipal Court, each Court retains its own identity; and

WHEREAS, the Shared Municipal Court shall be operated as four separate courts, pursuant to which Bedminster is the host municipality and provides the services described in this Agreement to Peapack and Gladstone, Bernardsville and Bernards; and

WHEREAS, the Shared Services Agreement, in the form attached hereto and made a part hereof, was negotiated and agreed to by Bedminster, Peapack-Gladstone, Bernardsville and Bernard which establishes a shared municipal court and provides for the sharing of court facilities and court staff including the municipal judge, court administrators, other court employees, prosecutors, public defenders and security personnel; and

WHEREAS, Bedminster, Peapack-Gladstone, Bernardsville and Bernards have negotiated a Shared Services Agreement, which is attached hereto and made a part hereof; and

WHEREAS, the Shared Services Agreement has been reviewed by the Township Attorney, along with representatives of the Township; and

WHEREAS, the Township Committee of the Township of Bernards finds it to be in the best interest of the Township and its residents to enter into this Shared Services Agreement with Peapack-Gladstone, Bernardsville, Bedminster, and Bernards for the establishment and operation of a shared municipal court.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Benards, in the County of Somerset, and State of New Jersey, as follows:

- 1. There shall be established a shared municipal court servicing the Township of Bedminster, Borough of Peapack and Gladstone, Borough of Bernardsville and Township of Bernards subject to compliance with the terms and conditions of the approval of Honorable Yolanda Ciccone, A.J.S.C.
- 2. The Mayor and Township Clerk are hereby authorized and directed to execute the attached Shared Services Agreement with the Borough of Peapack and Gladstone, the Borough of Bernardsville, the Township of Bernards, and the Township of Bernards, which Agreement sets forth the terms and conditions for the

- operation of the shared municipal court, including the sharing of court facilities and court staff including the municipal judge, court administrators, other court employees, prosecutors, public defenders and security personnel.
- 3. The Township Clerk/Administrator, Township Attorney and other appropriate Township officials are further authorized to take any and all action required to comply with this Agreement.
- 4. This Resolution shall take effect immediately upon adoption, and the adoption of the appropriate mechanism approving the Shared Services Agreement adopted by the Township.

<u>Resolution #2020-0218</u> - Support of Bernards Township's Participation in the "Mayor's for Main Street" Alliance

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of Bernards that we do hereby establish the following partnership agreement with the New Jersey Golf Foundation for the operation of the golf driving range:

- 1. The New Jersey Golf Foundation is to provide Commercial or Comprehensive General Liability insurance naming the Township as an additional insured with limits of not less than the following:
 - a. Combined Single Limits of Bodily Injury and Property Damage for
 - i. \$1,000,000.00 each occurrence (Bodily Injury & Property Damage)
 - ii. Umbrella Liability Insurance for a limit of liability of not less than \$2,000,000.00 each occurrence.
- 2. The New Jersey Golf Foundation is to sign a Hold Harmless waiver which shall indemnify and hold the Township harmless against any and all claims that should arise out of their operation of the golf driving range.
- 3. All expenses associated with the operation of the golf driving range is the sole responsibility of the New Jersey Golf Foundation. In turn, the New Jersey Golf Foundation is the sole recipient of all revenues associated with the operation of the golf driving range.
- 4. The New Jersey Golf Foundation shall be responsible for the payment of the annual usage fee direct to the Veterans Administration of 25% of the net revenues of the golf driving range or \$1,000.00, whichever is greater.
- 5. The term of this partnership agreement shall commence on May 27, 2020 and expire on March 21, 2021. At the conclusion of the 2020 operating season, both parties may review the current terms of the agreement and discuss options for renewal.

NOW, THEREFORE BE IT FURTHER RESOLVED by the Township Committee of the Township of Bernards that the Mayor be authorized to sign this agreement.
