Municipal Alliance News:

- Because there are no in-person events, there will be a push to promote awareness days and programs on Facebook.
 - Mental Health and Substance Abuse Awareness in October. Knock Out Opioid Abuse Day and other online programs.
 - Awareness Days: World Mental Health Day; OCD 10/11/20; Bully Prevention and Awareness
 - Try to post 2-3 days online per week and have programs wherever possible
- Quarterly Coordinator Meetings; try to run one big program with other Alliances.
 - o ie: Angst was well liked, try to coordinate online screenings and presentations.

- Somerset County Documentary Series. Invite all members coordinate times and dates to gauge the best accessibility
- o Try to have a longer window of time for people to view

- Ms. Harris wanted to know the best way the group could help Ms.
 Cartoccio with the process so she is not overwhelmed considering her work at the health department and the pandemic.
- Ms. Cartoccio wanted to know if any one had any ideas for programming. Right now, all is consumed with COVID-19 and we need a push for other ideas. (ie: opioids and depression)
- With the ideas Ms. Cartoccio can help coordinate publicity such as scheduled Facebook posts and resources.
- Mental Health ideas for kids were popular:
 - Helping kids in transition grades (K-6-9) connect to community and each other, especially of they are remote learning only.
 - Perhaps Alliance members could send uplifting messages to the kids weekly
 - Ms. Korn mentioned that the school counseling department also has many resources for the children, and we would not want to recreate what is already being done.
- At the County meeting on 10/19 they are getting federal money for mental health to hire people to form support groups. All ages and ideas welcome.
- Outreach to those on the outskirts was mentioned perhaps a company can be used that already creates and sends quick contacts.
- Constant Contact was suggested and also teaming with Community in Crisis. Perhaps online Narcan training.
- Rachael Talbert The young adult librarian from the Bernards Township Library was mentioned as a resource
- Looking at mental health programs and substance free activities for those in the community
