- A. 2023 Operating Schedule
 - The Pool Commission discussed the operating schedule for 2023. Changing weekend hours to match our weekday eight-hour shifts will further assist with staffing issues. We had to rotate area closures due to lack of lifeguards on several weekends.
- B. 2023 Operating Budget
 - The Pool commission discussed several changes to the 2023 operating budget including: mandatory minimum wage increases, bonus incentives and increased wages for lifeguarding staff, increased staff clothing costs and increased chemical costs. The budget will need to increase about \$50,000 for 2023.
- C. 2023 Membership and Guest Fees
 - The Pool Commission discussed adjusting the early deadline and increasing membership, gate and swim team fees for 2023.
- D. 2023 Membership Polices
 - J. Gander asked members to review and suggest possible changes at the next meeting. It was suggested that the weekday adult swim hours be adjusted in accordance with any operating hour adjustments.
