8. DISCUSSION ITEMS

- A. League Play & Facility Use
 - Tennis & Paddle Courts Jennifer Gander began discussion regarding Recreation Department policy on tennis and paddle court usage. She sought the committee's opinion on whether or not a permit (along with associated fees and insurance) should be required by a group when a league sanctioned game is being played on our courts and a referee or an official is present.
 - Grass Athletic Fields Jennifer indicated that similar usage without a permit has occurred on Township athletic fields. While a permit is required for the use of the turf fields (per ordinance) the same requirement is not applied to grass fields. There is no issue with pick up play or practice by children or adults, but when a league sanctioned game with a referee, umpire or other official is present, a permit should be required. This would provide group contacts to the department to ensure activities are cancelled when fields are closed and will also cover liability.

Committee members in attendance felt that a fee and insurance should be required and a permit issued in such league sanctioned tennis/paddle tennis games. Jennifer said will include fee structure on the 2019 fee structure listing she will submit to TC for approval.
