Dear Mr. Speeney:

On May 28, 2019 at approx. 1430 hours we received a call from the homeowner of #233 Madisonville Rd in Basking Ridge concerning a slight leak he discovered with his residential pumping system. BTSA collection system Forman was immediately dispatched to investigate. Upon arrival, our Forman confirmed the leak and determined that it only occurred when the homeowners pump came on. The nature of the leak was very slight and unmeasurable. Due to the nature and position of the leak, he was unable to determine if the problem was the homeowner's responsibility or ours. The homeowner was notified and instructed to curtail usage as much as possible. Messercola Excavating from Plainfield NJ was immediately contacted for the repair.

NJDEP non-emergency Hot Line was notified at 3:50 pm on 5/28/19 and was logged in by operator #85, case #19-05-28-1557-38.

Repair was completed at 12:00 pm on 5/29/19. Plant personnel remained on site for the duration of the repair.

The NJDEP hotline was notified at 1325 hours on 5/29/2019 to close out the incident and was logged in by operator #15, case #19-05-29-1325-07.
