<u>Smoke Testing/CCTV/Cleaning/I&I Repairs</u>: Suburban Consulting is still working with PSE&G to rectify two gas main intrusions. Lining to resume as soon as the issue has been rectified. Spoke to Mike M. on 9/30/22, he will call PSE&G again and request action ASAP.

Harrison Brook & Annin Rd CCTV: Tom drafted and submitted notification letters. Tentative date to resume work is 10/17/22 depending on response from homeowners.

**O2D High Flow Bypass:** Still in discussion with board members.
