The evaluation report was emailed to Melissa James, CFM – ISO/CRS Resource Specialist. The report was shared with the Township Committee via email. The report was made available to the media and public by posting a link on the Township's website; located in the Engineering Departments "Flood Information" section.**

3. Provide a description of the implementation of each recommendation or action item in the action plan or area analysis report, including a statement on how the project was implemented or not implemented during the previous year:

**BN1 – Participate in local, county, and/or state level projects and programs to develop improved structure and facility inventories and hazard datasets to support enhanced risk assessment efforts. – This initiative has not been**

implemented. The Township is willing to participate pending State/County initiative and appropriate funding.

**BN2 – Implement, review, and enforce municipal policies and programs to prevent trees from threatening lives and impacting power availability/interruption.** – This is an ongoing initiative, however more work needs to be performed with code enforcement and Shade Tree Commission.

**BN3 – Stormwater and Runoff Management** – This is an ongoing initiative. NJDEP has recently enacted new stormwater regulations that have been adopted by the Township. Additionally, when private developments are introduced, easements are imposed on properties in order to conserve environmentally sensitive areas, such as wetlands and steep slopes, as conditions of approval.

4. Discuss why any objectives were not reached or why implementation is behind schedule:

**BN2 and BN3 are ongoing initiatives that reviewed each year to determine ways to improve. BN1 is dependent on the County and State initiating programs and will require training, tools, and funding provided at the County, State, and/or Federal level.**

5. What are the recommendations for new projects or revised recommendations?

- **Replace a 300 ft long corrugated metal culvert that conveys stormwater to the Harrison Brook and is located within the flood hazard area. The existing pipe is severely deteriorated, and the receiving ditch filled with sediment.**
