NOW THEREFORE BE IT RESOLVED, that the Bernards Township Sewerage Authority will go into closed session for the following reason(s) as outlined in NJSA 10:4-12; and

NOW THEREFORE BE IT FURTHER RESOLVED, that the Bernards Township Sewerage Authority hereby declares that the discussion of subject(s) may be made public at a time when the Authority Attorney advises the Authority that the disclosure of the discussion will not detrimentally affect any right, interest or duty of the Township or any other entity with respect to said discussion. That time is currently estimated as the time of said matter.

NOW THEREFORE BE IT FINALLY RESOLVED that the Bernards Township Sewerage Authority, hereby declares that the public is excluded from the portion of the meeting during which the discussion(s) shall take place and hereby directs the Director to take the appropriate action to effectuate the terms of this resolution.

RESOLUTION #2150

Adopting an Information Security Policy, Cyber Incident Response Plan and Disaster Recovery Plan

WHEREAS, the purpose of creating an Information Security Policy, Cyber Incident Response Plan, and Disaster Recovery Plan is to formally establish the objectives and practices for sound data systems procedures for the Authority, and to clearly establish standard procedures in the event of a malicious cyber incident; and

WHEREAS, the Authority is a member of the Suburban Municipal Joint Insurance Fund (Suburban JIF) and the Municipal Excess Liability Joint Insurance Fund (MEL) who provide cyber insurance coverage for the Authority; and

WHEREAS, the Suburban Municipal Joint Insurance Fund and the Municipal Excess Liability Joint Insurance fund recommend such policies and response plans be formally adopted by the Authority; and

WHEREAS, compliance with the practices established in these policies will enable the Authority to claim reimbursement of a paid insurance deductible in the event the member files a claim against the Authority's cyber insurance policy, administered through the New Jersey Utility Authorities Joint Insurance fund and the Municipal Excess Liability Joint Insurance Fund; and

WHEREAS, the State of New Jersey considers it a "Best Practice" to have a formal cyber incident response plan.

NOW THEREFORE BE IT RESOLVED, by the Bernards Township Sewerage Authority of the Township of Bernards, Somerset County, New Jersey that there be and is hereby adopted an Information Security Policy, a Cyber Incident Response Plan, and a Disaster Recovery Plan for the Bernards Township Sewerage Authority subject to future revisions, a copy of both which are attached hereto and made a part hereof by reference.

EXPLANATORY STATEMENT

This resolution is a standard operating procedure for handling a cyber security incident. These step by step instructions are necessary for contacting the Municipal Excess Liability Joint Insurance Fund and providing the Authority assistance via the breach council and forensics and recovery professionals.

BE IT RESOLVED, that should Mystic Lobster Roll Company, change their service menu or operation or not maintain the smaller trap, the Authority may at its sole discretion require the installation of a larger grease trap; and

BE IT FURTHER RESOLVED, the undersink grease trap shall be subject to the same rules and regulations and inspections as any other grease trap installation and the Authority may require the installation of a 750 gallon grease trap within 30 days notice, at anytime the Authority deems necessary;

BE IT FURTHER RESOLVED, that a copy of this resolution be on file, available for public inspection in the office of the Bernards Township Sewerage Authority Director, 277 S. Maple Avenue, Basking Ridge, New Jersey 07920.
