# Minutes of the Special Meeting of the Board of Trustees of the Bernards Township Library March 18, 2020

## 1. CALL TO ORDER

President Kippy Piedici called the meeting to order at 7:55 p.m. via conference call.

#### 2. SUNSHINE LAW REMINDER

## 5. PUBLIC COMMENT

#### 6. DISCUSSION REGARDING THE EFFECT OF COVID-19 ON LIBRARY OPERATIONS

- Lyn summarized the steps taken and decisions made regarding library operations in response to the rapidly evolving COVID-19 pandemic:
  - o All spring semester Leisure Learning programs were cancelled.
  - After checking with other MAIN library directors, the Bernards Township Health Department, and the CDC [Cynthia joined the meeting at 8:03], the decision was made to close the library to the public at the end of the day Sunday, March 16, 2020, but to allow staff to work in the building.
  - On Monday, March 16, 2020 Lyn closed the building to the staff after seeking advisement from Bernards Township Health Officer Lucy Forgione.
  - Statewide Interlibrary Loan delivery service has been suspended indefinitely.
  - Staff is working at home completing previously deferred projects, planning for future programs and events, conducting programs online, and promoting ebooks and other online services.
- Kippy referred the Board to the "Policy on Inclement Weather and Other Emergency Closing," specifically the paragraph outlining pay implications for staff when there is a full-day closure. She then polled the Board for questions and comments.
- **MOTION 20-14** was made by Vivian Pagoulatos and seconded by Doug Roberts to continue paying part-time staff as long as the library is closed. With a roll call vote the motion passed 8-0-0.
- The Board agreed that should conditions improve the library could be reopened by Lyn and Kippy after consultation with the Township Health Department.

#### 7. PUBLIC COMMENT

There was public comment expressing appreciation for the action taken by the Board.

## 8. ADJOURNMENT

- MOTION 20-15 was made by Zina Pozner and seconded by Cynthia Yin to adjourn the meeting at 8:38 pm. The motion passed unanimously.
