WHEREAS, the Annual Budget and Capital Budget for the Bernards Township Sewerage Authority for the fiscal year beginning, 12-1-23 and ending, 11-30-24 has been presented before the governing body of the Bernards Township Sewerage Authority at its open public meeting of 9-12-23; and

WHEREAS, the Annual Budget as presented for adoption reflects Total Revenues of \$6,022,320 Total Appropriations, including any Accumulated Deficit, if any, of \$6,022,566 and Total Unrestricted Net Position utilized of \$246; and

WHEREAS, the Capital Budget as presented for adoption reflects Total Capital Appropriations of \$2,075,000 and Total Unrestricted Net Position planned to be utilized of \$0; and

WHEREAS, the schedule of rents, fees and other charges in effect will produce sufficient revenues, together with all other anticipated revenues to satisfy all obligations to the holders of bonds of the Authority, to meet operating expenses, capital outlays, debt service requirements, and to provide for such reserves all as may be required by law, regulation or terms of contracts and agreements; and

WHEREAS, the Capital Budget/Program pursuant to N.J.A.C. 5:31-2, does not confer any authorization to raise or expend funds; rather it is a document to be used as part of the said Authority's planning and management objectives. Specific authorization to expend funds for the purposes described in this section of the budget, must be granted elsewhere; by bond resolution, by a project financing agreement, by resolution appropriating funds from the Renewal and Replacement Reserve or other means provided by law.

NOW, THEREFORE BE IT RESOLVED, by the governing body of the Bernards Township Sewerage Authority, at an open public meeting held on 9-12-23 that the Annual Budget, including all related schedules, and the Capital Budget/Program of the Bernards Township Sewerage Authority for the fiscal year beginning, 12-1-23 and ending, 11-30-24 is hereby approved; and

BE IT FURTHER RESOLVED that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Authority's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED that the governing body of the Bernards Township Sewerage Authority will consider the Annual Budget and Capital Budget/Program for adoption on 11-21-23.

RESOLUTION #2341 PROFESSIONAL SERVICES CONTRACT

Awarding a Professional Services Contract for 2024-2026 Risk Management Consulting Services RSC Insurance Brokerage, Inc.

WHEREAS, the Bernards Township Sewerage Authority requires professional Risk Management Services; and

WHEREAS, RSC Insurance Brokerage, Inc., 21 Commerce Drive, Suite 302 Cranford, NJ 07016, has submitted a proposal in the form of a draft agreement outlining their professional risk management consulting services required in the bylaws of the New Jersey Utility Authorities Joint Insurance Fund of which the Authority is a member; and

WHEREAS, section N.J.S.A. 40A:11-5 of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) exempts such professional services from competitive bidding.

WHEREAS, this professional services contract is not subject to the requirements of N.J.S.A. 19:44A-20.4, *et seq* and Section 2-34 of the "Township Ordinances" as the Contract is under the threshold for the ordinance as well; and

NOW THEREFORE BE IT RESOLVED, by the Bernards Township Sewerage Authority that a professional service contract for Sewerage Authority Risk Management Services be awarded to RSC Insurance Brokerage, Inc and;

- 1. This contract shall, for all purposes, be deemed a New Jersey Contract and any provision of this contract shall be governed and interpreted with the Laws of the State of New Jersey.
- 2. Any modification to this contract shall be in writing and signed by both parties and upon obtaining said signatures shall immediately become part of the contract.
- 3. The term of this agreement shall be for three years, from January 1, 2024, to January 31, 2027, unless terminated as hereinafter provided in this agreement. The Authority authorizes the Fund to pay its Consultant as compensation for services rendered an amount equal to six percent (6%), of the Authorities assessment as promulgated by the New Jersey Utility Authorities Joint Insurance Fund.
- 4. Either party upon thirty days written notice via certified mail may terminate this contract. The line item appropriation or ordinance to be charged is 4-01- -802-211.
